# 2025 national energy storage subsidy policy

On 15 July, national plans for energy storage were set out by the Chinese National Development and Reform Commission and National Energy Administration. Energy-efficiency subsidies (Figure 8) have increased since 2015 and by 2022 had reached EUR 30 billion (EUR 8 billion more than in 2021). In recent years, the United States has enacted significant legislation (the Infrastructure Investment and Jobs Act in 2021 and the Inflation Reduction Act of 2022) that will spur greater development of domestic renewable energy resources. March 04, 2024. Energy storage resources are becoming an increasingly important component of the energy mix as traditional fossil fuel baseload energy resources transition to renewable energy sources. There are currently 23 states, plus the District of Columbia and Puerto Rico, that have ...

In the Presidential Decree No. 22/2017 on the National Energy Plan, the government estimated that the renewable energy mix would rise to 23% by 2025 and 31% by 2050 (RUEN, 2017). However, with the current progress, it will be an uphill battle for Indonesia to achieve the target on time let alone accomplishing the net-zero emission.

The EUR100 million (US\$106 million) allocation is part of a EUR416 million package for PV co-located battery energy storage system (BESS) technology that was initially to total EUR41.6 million a year, starting in 2025, for ten years. The 2025 programme is set to open on 1 January 2025, and more details will be released to the House later this year.

The Energy Storage Roadmap was reviewed and updated in 2022 to refine the envisioned future states and provide more comprehensive assessments and descriptions of the progress needed (i.e., gaps) to achieve the desired 2025 vision.

In the context of the "dual-carbon" goal and energy transition, the energy storage industry's leapfrog development is the general trend and demand. The follow-up actions will inevitably introduce a series of policies for the development of energy storage to eliminate industrial development. Faced with "obstacles" one
