When considering starting an investment as an energy storage facility, it is necessary to apply the Energy Law, which contains regulations for this type of installation. The main regulatory obligations in Poland depend on the total installed capacity of a given storage facility.

With regulatory changes expected in early 2025, the potential for Poland is huge and this panel will outline some of those big opportunities. What is the most sustainable business model for energy storage in Poland? What further revenue streams can come from the capacity market in Poland and how will an ancillary services market complement this?

The energy transition is an opportunity for Poland to develop new economic sectors and create new jobs. The transition could boost domestic growth by 1-2 per cent and create 300,000 new jobs by 2050. Promising sectors include electric vehicle manufacturing, offshore wind, and the production of electric heat pumps.
