Spain has increased its energy storage target by 2030 to 22.5GW in the latest update of its National Energy and Climate Plan (NECP). The Spanish government, through the Ministry of Ecological Transition (MITECO), has passed a royal decree that updates the country's NECP targets between 2023-2030.

Within the area of climate and furthering the clean energy economy, Governor Hochul set out actions to be taken to directly advance energy storage technologies in New York: creating a new battery research and manufacturing centre and doubling the state's energy storage deployment target from 3GW by 2030 to 6GW by that year.

Today, we are publishing Master Plan Part 3, which outlines a proposed path to reach a sustainable global energy economy through end-use electrification and sustainable electricity generation and storage.
