The FCC regulates radio frequency (RF) devices contained in electronic-electrical products that are capable of emitting radio frequency energy by radiation, conduction, or other means. These products have the potential to cause interference to radio services operating in the radio frequency range of 9 kHz to 3000 GHz.

According to UL Solutions, installation codes such as the International Residential Code and the NFPA 855 require energy storage systems to be listed according to the requirements in UL 9540.

FCC certification and the importance of compliance . Products covered by FCC regulations include consumer technology devices, lighting devices, appliances, industrial devices, and wireless devices with Bluetooth ®, Wi-Fi, Zigbee ® and/or cellular connectivity. For manufacturers of these products to export a product into the United States, FCC certification must be achieved.

Jurisdictions with significant investment in renewable energy sources, such as California, Hawaii, and New York, are more likely to adopt or reference NFPA 855 due to the integral role of ESS in grid stability, energy storage, and renewable energy integration.

1. FCC testing & certification. Federal Communication Commission (FCC) is the independent agency of the United States government that regulates the radiation standards of electronic devices. Nearly all products emitting radio frequency energy must be tested by FCC listed or accredited lab and certified by the FCC for EMC/Telecom compliance.

Most products covered by New Approach Directives can be self-certified by the manufacturer and do not require the intervention of an EU-authorized independent testing/certifying company (notified body). To self-certify, the manufacturer must assess the conformity of the products to the applicable directives and standards.

UL 9540A testing includes progressively larger-scale fire tests to evaluate the risk of thermal runaway and fire propagation in battery energy storage systems.
