Armenia's energy system depends primarily on natural gas, nuclear and hydroelectricity. Natural gas is by far the largest contributor to total energy supply (TES), as well as the main energy carrier in total final consumption (TFC). Since the transport sector depends primarily on natural gas, the importance of oil in the economy is relatively low.

Armenia has significant solar energy potential: average annual solar energy flow per square metre of horizontal surface is 1 720 kWh (the European average is 1 000 kWh), and one-quarter of the country"s territory is endowed with solar energy resources of 1 850 kWh/m 2 per year. Nuclear energy plays a vital role in the development agenda of Armenia. Being a country with an operating nuclear power plant, Armenia opted for a transparent and open policy for safe and peaceful uses of nuclear energy and continuously undertakes necessary measures to enhance and maintain nuclear and radiation safety.

The European Bank for Reconstruction and Development, IFC, a member of the World Bank Group; and the European Union (EU) have agreed to support the development of the first utility-scale solar power plant in Armenia, which is also the first for the Caucasus.. Belarus commissioned its first nuclear power plant (NPP) in 2021, and a number of activities were carried out within the framework of Armenia's agreement to assist Belarus. According to a 2008 Energy Charter report, Armenia's oil product storage facilities are of adequate capacity, as requirements far exceed annual consumption.

The plant, which will supply power to the Houston area, has already signed one commercial and industrial (C& I) power purchase agreement (PPA) and another PPA with an energy trading company.

Armenia depends on imports to meet much of its energy needs, particularly natural gas from the Russian Federation. It is one of the few ex-Soviet republics to avoid significant energy subsidies, and it is the only country in the Caucasus region to possess a nuclear power plant.

Eduard Martirosyan, director general of the Armenian nuclear power plant, said the country was " closely following global decarbonisation trends". He said the existing nuclear power plant " generates about 40% of all electrical power in the country and since 1977 has been a clean and reliable source of power".

The largest utility-scale solar power plant in Armenia will be located in Mets Masrik municipality, in the Gegharkunik region. The 55 MW solar power plant is the first-of-its-kind in the country, whereas the Armenian government has allocated 32.6591 ha of area for this project with its decision 326-L dated on 29 March 2019.
