The new standard AS 5139 applies to batteries installed in a fixed location whose voltage is at least 12 volts and whose energy storage capacity is at least 1 kilowatt-hour (kWh). The standard applies to homes, garages, sheds and commercial properties but not to caravans, tiny homes with wheels, electric vehicles, uninterruptible power supplies ...

(iii) manufacturer's specified energy capacity, for other technologies. Where an installation includes multiple battery energy storage systems, this Standard applies to each individual battery energy storage system if -- (A) the total energy storage capacity is equal to or greater than 1 kWh; and (B) each individual BESS is no more than 200 kWh.

Australian solar battery storage standards: Ensuring safety and performance. Australian solar battery systems are governed by a set of rigorous standards, primarily AS/NZS 5033 for solar panels and AS/NZS 5139 for batteries.
