Energy storage battery fires are decreasing as a percentage of deployments. Between 2017 and 2022, U.S. energy storage deployments increased by more than 18 times, from 645 MWh to 12,191 MWh, while worldwide safety events over the same period increased by a much smaller number, from two to 12.
