



# Battery energy storage value

Battery storage degradation typically manifests as a loss of energy retention capacity, reduction in power delivery capability and efficiency, and eventually need for replacement of batteries. Depending on the state of a battery system, replacement might imply only the change of few worn out modules or a total replacement.

For purposes of comparison, the current storage energy capacity cost of batteries is around \$200/kWh. Given today's prevailing electricity demand patterns, the LDES energy capacity cost must fall below \$10/kWh to replace nuclear power; for LDES to replace all firm power options entirely, the cost must fall below \$1/kWh.
