The following good practice guidance relates to lithium-ion battery BESS installations and is intended primarily for detached, semi-detached, and terraced dwellings, and ...

Consideration should be given to keeping BESS separate from combustible construction and storage, and away from living spaces (bedrooms, living rooms). Garages (with good separation/protection from vehicles) or similar unoccupied utility spaces with suitable fire-separation are the best choice for indoor residential BESS installations.

Energy storage battery fires are decreasing as a percentage of deployments. Between 2017 and 2022, U.S. energy storage deployments increased by more than 18 times, from 645 MWh to 12,191 MWh, while worldwide safety events over the same period increased by a much smaller number, from two to 12.

UL 9540A--Test Method for Evaluating Thermal Runaway Fire Propagation in Battery Energy Storage Systems implements quantitative data standards to characterize potential battery storage fire events and establishes battery storage system fire testing on the cell level, module level, unit level and installation level.

To minimise the risk of batteries becoming a fire hazard, a new British Standard covering fire safety for home battery storage installations came into force on 31 March 2024. The standard is - PAS 63100:2024: Electrical installations. Protection against fire of battery energy storage systems (BESS) for use in dwellings.

The Draft of the new PAS 63100 standard for protection against fire of battery energy storage systems for use in dwellings is now available for public comment on BSI's Standards Development web-site. The public commenting period commences 26 June 2023, and on closes on 24 July 2023.

UL 9540A, a subset of this standard, specifically deals with thermal runaway fire propagation in battery energy storage systems. The NFPA 855 standard, developed by the National Fire Protection Association, provides detailed guidelines for the installation of stationary energy storage systems to mitigate the associated hazards.

Just four months after this incident, the National Fire Protection Association (NFPA) debuted the first edition of NFPA 855, Standard for the Installation of Stationary Energy Storage Systems. The release of NFPA 855 was a three-year effort to address fire safety concerns related to ESS installation and operation.
