This post will help you understand how a unit can be sold to the highest bidder. In Texas, the owner of the storage facility has the power to sell your belongings if you do not pay for your storage unit. This power comes either from a court judgment or from the contract signed between you and the storage facility.

An electrical panel can be installed in a storage room, but there are multiple restrictions in the National Electrical Code: 1) There must be a clear working space in front of the panel that is 30" wide by 36" deep, per NEC 110.26(A). ... Insurance premiums for storage facilities offering electricity would naturally be higher due to the increased risks. Storage businesses can maintain lower insurance costs and reduce potential legal liabilities by forgoing the electricity option. Electricity within storage units adds an operational layer of complexity.

The owner can sell the contents of your storage unit if no payment has been received for a continuous 30 day-period after you default. At any time before the sale of your belongings, you may pay the amount necessary to satisfy the lien and the reasonable expenses incurred and get your belongings back.

No. Your storage unit must be located at an allowed storage facility. See Private Seller Rules/Location of Unit. I want to sell at different storage facilities. How do I add the different locations to my Private Seller account? Private Sellers can post auctions from multiple storage facilities on StorageTreasures under one user account.

It is likely illegal for them to sell such items KNOWINGLY, but most self storage laws do not require operators to inspect the entire contents of the unit for auction. Operators are required to provide a general description of the property in the legal advertisement, so they do need to have a general idea of what is in the unit.
