The Commission also adopted a single-part tariff structure, comprising capacity charges of INR5.7million (~\$68,981)/MW per year.

The projects will be set up in Dasna, Hasayan, Jalesar, Boner, and Vrindavan. The projects will be set up under build, own, operate, and transfer mode for 12 years. The work must be completed within 18 months of signing the Battery Energy Storage Purchase Agreement (BESPA). The last day to submit the bids is December 24, 2022.

Over a gigawatt of bids from battery storage project developers have been successful in the first-ever competitive auctions for low-carbon energy capacity held in Japan. A total 1.67GW of projects won contracts, including 32 battery energy storage system (BESS) totalling 1.1GW and three pumped hydro energy storage (PHES) projects totalling 577MW.

In late January, Energy-Storage.news covered French developer Neoen's announcement of Yllikk&#228;l&#228; Power Reserve Two (YPR2), a 56.4MW/112.9MWh BESS set to be Finland - and the Nordics" - biggest project to date by megawatt-hours.
