



Car battery recycling energy storage project

The International Renewable Energy Agency projects that 78 million metric tons of solar panel waste could accumulate by 2050. The possible recovery of that waste could be worth as much as \$15 billion. The average useful life of a solar PV module is approximately 30 years. A lithium-ion car battery can last as long as 10 to 20 years.

Nevertheless, spent batteries may also present an opportunity as manufacturers require access to strategic elements and critical materials for key components in electric-vehicle manufacture: recycled lithium-ion batteries from electric vehicles could provide a valuable secondary source of materials.

Although at the global level, there remains a lack of clear legislative and regulatory frameworks for the process of repurposing used EV batteries for energy storage, some real instances already exist in which retired EV batteries are repackaged and employed for storage of solar energy.
