Cnooc develops energy storage project

Shell has signed a Joint Study Agreement with CNOOC, Guangdong Provincial Development and Reform Commission and ExxonMobil for the Daya Bay carbon capture and storage (CCS) hub project in China. It is a significant step forward in developing this joint project after we signed the Memorandum of Understanding for the project in June last year.

CNOOC anticipates the addition of 48 production wells for the project to achieve peak production in 2024 of approximately 35,500 bbl/day of crude oil. CNOOC Limited acts as the operator of Enping 15-1/10-2/15-2/20-4 oilfields joint development project and holds 100% interest.
