

The ANH will soon become the National Energy Agency (ANE). The first steps in this direction have already been taken. In 2023, the ministry, through resolution 40234, gave us the responsibility to support and develop policies that promote geothermal energy, wind energy, hydrogen, and the potential for CO2 capture and storage.

It is interesting to note that in Colombia, gas producers and marketers are required to submit their production plan each year to the MME for each field for a ten-year period. They can update this information during the year. The UPME prepared the 2019-2028 Natural Gas Supply Plan, based on the MME resolution (40304/2020).

Colombia has crude oil storage (7 mb) and oil product storages (3 mb), alongside upstream storage capacity of 3.5 mb, or 4 days of production.
