

Current status of energy storage in the uk

The facility, which is 18 miles off the coast of East Yorkshire, stopped storing gas in 2017 but was re-opened for gas storage in October 2022. Rough now provides half of the UK's total gas storage. At the time of reopening Rough for gas storage it was able to store approximately 30 billion cubic feet (bcf) of gas for UK homes and businesses.

Stephen Crosher, Chief Executive of RheEnergise Ltd said: Over the next decade, Long Duration Energy Storage can make an important contribution to the UK energy market, and indeed globally. Long Duration Energy Storage is a key to delivering the energy transition and will help strengthen the resilience and security of the UK's energy system.

On 15 May 2023 the UK produced its trillionth kilowatt hour (kWh) of electricity generated from renewable sources - enough to power UK homes for 12 years based on average consumption. While it took 50 years to reach this milestone, based on current projections it will take just over five years to reach the next trillionth kWh.

It is clear that the role of energy storage within the UK's electricity system is recognised, but the current level is still a small proportion of what is expected over the next 10 years: National Grid scenarios indicate up to 8 GW of new storage capacity is needed by 2030. In particular, there is a need for storage that can capture surplus ...

One of the challenges for energy storage development is that data from operational facilities is not generally available. Knowledge of how energy storage technologies actually perform under different conditions is extremely valuable to researchers.

Current market arrangements do not adequately reward energy storage over longer timeframes, particularly over seasons and years. The Government are reviewing electricity market arrangements for the GB power system, which will impact the potential business cases of LDES assets. Key messages

The energy storage market in the UK is currently experiencing substantial growth, as evidenced by the current operational capacity of 4.6GW/5.9GWh, projected to increase to 7.4GW/11.6GWh by the end of 2024. ...

The UK Energy Research Centre (UKERC) found that 45%-47% of total final energy consumption in the country is used for heating purposes currently, with 80% of it derived from fossil fuels. "Of the 18% of heat supplied for industrial processes, 6% is for high-temperature processes, 9% for low-temperature processes and 3% for drying and separation.
