The working principle of an energy storage inverter is basically to extract electricity from the energy storage system (such as a battery), convert DC electricity into AC electricity, and output it to the grid or load.

In September 2023, the domestic exports of energy storage inverters amounted to \$650 million, marking a 33% year-on-year decrease and a 6% month-on-month decline. The number of PV and energy storage inverters exported in September stood at 3.91 million units, down by 23% compared to the previous year and 3% on a month-to-month basis.

In the Budget 2021, the Finance Minister proposed to raise the customs duty on solar inverters from 5% to 20% and on solar lanterns from 5% to 15% to encourage domestic production.
