

# Danish new energy storage project bidding

Based on partial statistics, there were 26 new energy storage bidding projects in June, with a combined capacity of 7.98GWh. Among them, framework procurement projects accounted for 4.4GWh, household energy storage projects accounted for 2.6GWh, and new energy distribution storage projects accounted for 0.9GWh.

Based on Energinet's analysis and on the basis of the dialogue with member states and the public consultation, the Danish Energy Agency on 15 December 2023 has notified the European Commission and ACER (Agency for the Cooperation of Energy Regulators) that Denmark has decided to establish the new bidding zone DK3 at Energi&#248; Bornholm. The Danish Energy Agency granted the first-ever permit for a CO2 storage project in Denmark at the end of 2022, awarded to the Greensand Pilot Injection Project. The permit allows up to 15,000 tonnes of CO2 to be injected in the project's pilot phase, in the former Nini West oil field, and is valid for a period of four months, expiring on 1 ...
