The Philippines Department of Energy (DOE) has outlined new draft market rules and policies for energy storage, a month after the country allowed 100% foreign ownership of renewable energy assets.

The energy landscape is quickly changing, propelled by the need for domestically secure cleaner, greener energy. Battery energy storage is key to harnessing the power of renewable energy. Multiple battery chemistries, including lead batteries, are pivotal in maximizing both the power and sustainable impact of renewable energy sources.

In 2022, wind farms received \$273 million to not operate. Battery storage systems help reduce the need for curtailment payments. The UK has 2.4GW/2.6GWh of operational energy storage across 161 sites, with 20.2GW additional approved in planning. The UK is deploying increasing amounts of new utility energy storage capacity each year.
