Energy storage battery fires are decreasing as a percentage of deployments. Between 2017 and 2022, U.S. energy storage deployments increased by more than 18 times, from 645 MWh to 12,191 MWh, while worldwide safety events over the same period increased by a much smaller number, from two to 12.

Battery energy storage systems shall have a perimeter fence of at least 7 feet in height, consistent with requirements established in NFPA 70.4 Battery energy storage systems shall also comply with specifications established in NFPA 855 relating to barriers and buffering.<sup>5</sup>

Energy charged into the battery is added, while energy discharged from the battery is subtracted, to keep a running tally of energy accumulated in the battery, with both adjusted by the single value of measured Efficiency. The maximum amount of energy accumulated in the battery within the analysis period is the Demonstrated Capacity (kWh)
