An energy storage system is something that can store energy so that it can be used later as electrical energy. The most popular type of ESS is a battery system and the most common battery system is lithium-ion battery.

The diagram shows that each ESS unit can have a maximum rating of 20 kWh, and if you're going to install two units, let's say outside on your wall, you need to have the appropriate spacing between those units and three-feet separation from doors and windows per NFPA 855 15.6.1.

In energy storage systems, accidents caused by leakage of batteries due to thermal runaway are the industry's biggest risk points. The NFPA of the United States has issued an installation standard "NFPA 855" specifically for ESS, which strictly regulates the system capacity and installation distance of ESS batteries.

Individual ESS units shall have a maximum stored energy of 20 kWh per NFPA Section 15.7. NFPA 855 clearly tells us each unit can be up to 20 kWh, but how much overall storage can you put in your installation? That depends on where you put it and is defined in Section 15.7.1 of NFPA 855.

The size requirements limit the maximum electrical storage capacity of nonresidential individual ESS units to 50 KWh while the spacing requirements define the minimum separation between adjacent ESS units and adjacent walls as at least three feet.
