



# Energy storage contract energy management

In August 2020, the CPUC approved seven clean energy contracts for PG& E to procure 717 MW of resource adequacy capacity. In November 2021, the CPUC approved an 80 MW energy storage contract submitted by SDG& E to serve summer reliability in Summer 2022.

This course covers the key issues and provisions that need to be considered when negotiating these energy storage contracts and agreements: Capacity or Tolling Agreement (sometimes called an energy storage PPA) BESS Supply Agreement / Energy Storage Services Agreement / Energy Management Services Agreement; Balance of Plant / EPC Agreement

The deal has been agreed for Giga's 300MW/1,200MWh Leopard project in Vlissingen, northern Netherlands, on which construction should start this year, as told to Energy-Storage.news by the firm's CCO Lars Rupert in June. The time limited contract becomes active on 1 October, 2025, although Giga has previously said Leopard would come online in 2026.

For standalone energy storage contracts, these are typically structured with a fixed monthly capacity payment plus some variable cost per megawatt hour (MWh) of throughput. For a combined renewables-plus-storage project, it may be structured with an energy-only price in lieu of a fixed monthly capacity payment.

Ontario's electric grid operator, the Independent Electricity System Operator (IESO), has awarded contracts for what will be the largest battery energy storage projects (BESS) in Canada, at 390 MW and 380 MW. However, they could soon be overtaken by a proposed 500 MW project that is slated to come online in a similar timeframe.
