Electrostatic charge generation: Due to the very low minimum ignition energy characteristics of hydrogen, some weak ignition sources, such as electrical equipment sparks, electrostatic sparks, and frictional impact sparks, are sufficient to cause ignition in hydrogen-air combustible mixtures (Dryer et al., 2007).

Ultimately, energy storage safety is ensured through engineering quality and application of safety practices to the entire energy storage system. Design and planning to prevent emergencies, and to improve any necessary response, is crucial.
