Off-gassing occurs when gasses are released from the battery cells due to overheating or other malfunctions, which can result in the release of potentially hazardous amounts of gasses such as hydrogen, carbon monoxide, and methane.

Most battery ESS units are now required by NFPA 855 and model fire codes to be listed to UL 9540, Energy Storage Systems and Equipment [5]. While there is an allowance in NFPA 855 for a field evaluation to be performed for non-listed ESS, UL 9540 requirements provide valuable information related to how the battery ESS reacts in a thermal event.

As global demand for renewable energy storage systems expands, so does its significance as a fire safety solution. Such measures are essential to electrochemical energy facilities like battery storage stations to prevent and mitigate potential fire incidents and protect personnel and equipment integrity.
