The year 2023 has been a significant one for lessons learned within the energy storage industry, particularly underscoring that battery safety demands heightened scrutiny. The occurrence of multiple incidents throughout the year has unequivocally demonstrated that maintaining the safety of batteries is an intricate and non-trivial task.

New Energy World embraces the whole energy industry as it connects and converges to address the decarbonisation challenge. It covers progress being made across the industry, from the dynamics under way to reduce emissions in oil and gas, through improvements to the efficiency of energy conversion and use, to cutting-edge initiatives in renewable and low ...

Finally, energy storage manufacturers should make as much third-party testing information as possible publicly available to offer full transparency into the industry's safety process.

Energy storage battery fires are decreasing as a percentage of deployments. Between 2017 and 2022, U.S. energy storage deployments increased by more than 18 times, from 645 MWh to 12,191 MWh, while worldwide safety events over the same period increased by a much smaller number, from two to 12.

Our recent article in IEEE Power and Energy Magazine offered a basic roadmap for establishing a predictive maintenance approach for a BESS.
