Integrating energy storage with fossil-fuel plant decommissioning strategies offers benefits for wide range of stakeholders in the energy system (Saha 2019). For federal, state, and local governments, replacing fossil-fuel power plants with storage capacity could support their decarbonization and energy transition goals.

The scope of decommissioning generally includes decontamination, removal/dismantling of disused plant and buildings, spent fuel storage or disposition, waste management, transport, and final disposal or long-term storage.

The coal-fired power station, located in Victoria's Latrobe Valley, closed its doors in March 2017. The plant capacity was 1600MW with eight 200MW boiler/turbine units with fuel supplied by an adjacent open cut brown coal mine via continuous mining equipment. Hazelwood supplied approximately 22 per cent of Victoria's energy requirements.

In all three power plant decommissioning strategies, storage plays the dual role of enabling the reduction of non-RE sources from the grid, while enabling increased RE integration into the electric grid (Table 4).
