The DOE data is current as of February 2020 (Sandia 2020). Pumped hydro makes up 152 GW or 96% of

When the wind power surpasses the load demand, the energy is kept by energy storage station. In case of insufficient wind power to satisfy the load need, the energy storage station releases electricity.
