Ensuring"acceleration zones, wind and solar PV parks, and energy storage projects, Germany's federal cabinet on Wednesday approved a draft law aimed at shortening the project approval process, a move that fulfills the requirements of the European Union's 2023 Renewable Energy Directive.

As of April 1, 2024, New York has awarded about \$200 million to support approximately 396 megawatts of operating energy storage in the state. There are more than 581 megawatts of additional energy storage under contract with the State and moving towards commercial operation.

The award is one of three approved under the CEC"s Long-Duration Energy Storage program, which is part of Governor Gavin Newsom's historic multi-billion-dollar commitment to combat climate change. The program invests in demonstration of non-lithium-ion technologies across the state to create a diverse portfolio of energy storage technologies.

In July 2024, two new battery energy storage systems reached commercial operations in ERCOT. Each site is a 9.9 MW/9.9 MWh site in the South Load Zone. This brings the total installed rated power of batteries in ERCOT to 5,305 MW. Total installed energy capacity now sits at 7,437 MWh.. This meant the ratio of installed energy capacity to rated power ...

Earlier this year, the East River Energy Storage Project was issued a negative declaration under the New York State Environmental Quality Review Act and is slated to begin operations in 2023.
