Safety: Minimum safety and operating requirements are common considerations for energy projects. Energy storage resources present additional safety concerns given their unique technological profiles. For battery storage technologies in particular, safety requirements should adequately address fire risks.

Table 1 summarizes types of energy storage and RTPs used in related literature to the planning problem of IES.
