

Some PPAs for new energy storage resources have been structured as capacity-only contracts in which the developer is responsible for the sale of energy and all costs associated therewith--including the costs of the required energy procured from the utility.

Arizona utility Salt River Project (SRP) has signed an agreement for full dispatch rights to a new 250MW/1,000MWh battery energy storage system (BESS) project. SRP announced last week (18 July) that the contract has been signed for Signal Butte, a standalone BESS project in Mesa, Arizona, US, with developer Aypa Power.

Under an energy storage tolling agreement, the developer of the energy storage system is responsible for obtaining site control, permits, interconnection rights, equipment, and construction contracts, as well as achieving agreed-upon milestones such as a target commercial operation date and a guaranteed commercial operation date.

For standalone energy storage contracts, these are typically structured with a fixed monthly capacity payment plus some variable cost per megawatt hour (MWh) of throughput. For a combined renewables-plus-storage project, it may be structured with an energy-only price in lieu of a fixed monthly capacity payment.
