Energy arbitrage is the time shifting of energy to make money from buying low and selling high. Due to the nature of such an arbitrage the first hour of storage, when the system charges at the lowest-priced hour of the day and discharges at the highest-price hour, will be the most valuable, followed by the second hour of duration, and so on.

While energy storage technologies are often defined in terms of duration (i.e., a four-hour battery), a system"s duration varies at the rate at which it is discharged. A system rated at 1 MW/4 MWh, for example, may only last for four hours or fewer when discharged at its maximum power rating.

For safe and long-lasting batteries, it is recommended not to exceed a 0.25 C-rate. This means that no more than 25% of the battery's total electricity storage will be cycled per hour. Or in other words, the charge time of a lithium ion battery should not be less than 4-hours, and the total discharge time at full capacity should be 4-hours.
