Today's Northern Power Systems started in 2014 as the operational branch of Northern Power Systems Inc in Italy, successfully installing and managing over 450 plants in 4 years.

A recent study by Italian Transmission Operator (TSO) TERNA estimated that the grid needs about 71 GWh of new utility-scale storage capacity by 2030 for the country to decarbonize its energy system in line with EU targets. This means a massive deployment of around 19 GW of large-scale energy storage capacity by 2030.

The Italian legislator has acted to guarantee a long-term supply system of new storage capacity by introducing a mechanism based on competitive, transparent and non-discriminatory auctions. The system recognises the right to an annual remuneration, in exchange for the provision of the awarded capacity as part of the national energy market.

The remaining capacity will be used for energy arbitrage. Gabriele Buccini, head of utility storage at Trina Storage said: "Commissioning our first utility storage system in Italy is a significant milestone for Trina Storage and the wider Trinasolar group.
