Field's expansion into Spain comes as the business grows its operations - with >4.5 GWh of projects currently in advanced stages of development across Europe. Toni Martinez, General Manager, Field Spain : "We're seeing an increase in renewable energy generation in Spain as we make significant strides to deliver our decarbonisation strategy.

These studies point to more than 200 GW and 600 GW of energy storage capacity by 2030 and 2050 respectively (from roughly 60 GW in 2022, mainly in the form of pumped hydro storage). The EU needs a strong, sustainable, and resilient industrial value chain for energy-storage technologies.

EASE, together with the European Energy Research Alliance, will be part of the Batteries Europe's consortium coordinated by InnoEnergy. EASE, along with its members, will support this platform thanks to its expertise in research and innovation in the battery field, promoting the development of a sound battery industry in Europe.

In Europe, there is a growing consensus amongst policymakers that energy storage is crucial to securing affordable and low carbon energy. In May 2022, European Union launched their REPowerEU plan, a part of the European Green Deal, which mandates that 45% of Europe's energy generation needs to come from renewable sources by 2030.

EASE supports the creation of a policy and regulatory framework that allows energy storage to compete on a level playing field, and drives investments in energy storage research development, innovation, and deployments to develop a sustainable and competitive industry in Europe. ... EASE is committed to strengthening the European energy storage ...

It can also facilitate the electrification of different economic sectors, notably buildings and transport. The main energy storage method in the EU is by far "pumped hydro" storage, but battery storage projects are rising. A variety of new technologies to store energy are also rapidly developing and becoming increasingly market-competitive.

Battery-based energy storage already plays a critical role in supporting energy security across Europe. Using storage to provide fast-responding frequency regulation services and reinforcing grid infrastructure are critical for system stability, but the role of capacity markets should not be ignored.

Many European energy-storage markets are growing strongly, with 2.8 GW (3.3 GWh) of utility-scale energy storage newly deployed in 2022, giving an estimated total of more than 9 GWh. Looking forward, the International Energy Agency (IEA) expects global installed storage capacity to expand by 56% in the next 5 years to reach over 270 GW by 2026.
