As the world was starting to recover from the COVID-19 emergency, in early 2022 another crisis struck: with the Russian invasion of Ukraine starting in late February, almost the entirety of the European Commission activities for 2022 shifted away from the foreseen Working Programme to focus on sanctions and new measures to ensure security of supply. ...

In 2022 alone, European grid-scale energy storage demand will see a mighty 97% year-on-year growth, deploying 2.8GW/3.3GWh. This reflects energy storage's emergence as a mainstream power technology. Over the next decade, the top 10 markets in Europe will add 73 GWh of energy storage, amounting to 90% of new deployments.

The Commission adopted in March 2023 a list of recommendations to ensure greater deployment of energy storage, accompanied by a staff working document, providing an outlook of the EU's current regulatory,

market, and financing framework for storage and identifies barriers, opportunities and best practices for its development and deployment.

Quite the opposite, Europe ended winter with a remarkable milestone for its energy sector: EU gas storages were almost 60% full, a record amount. This didn't grab the headlines, but it matters. Because it shows that Europe has finally loosened the grip that Russia had over its energy sector. Europe has taken its energy destiny back into its own ...
