A finding of dumping. The following can take place where, based on its investigation, the Commission considers that dumping has occurred. Anti-dumping measures may be imposed on imports of the product concerned into the EU, which generally take the form of: an ad valorem duty -- a percentage of the import value of the product concerned;

Apart from regular customs duties, a product can also be subject to anti-dumping or other trade defence instruments. Dumping occurs when a company exports a product at a lower price than the product's normal value in its home market. This normal value could be the domestic price of the product, or the cost of production.
