The energy equivalent of as much as 1.3 million electric car batteries and could heat a medium-sized Finnish city all year round. A seasonal thermal energy storage will be built in Vantaa, which is Finland's fourth largest city neighboring the capital of Helsinki.

The four projects offered in the tender include the 500-MW Al-Muwyah and 500-MW Haden battery energy storage projects in Makkah province, the 500-MW Al-Khushaybi project in Al-Qassim province and the 500-MW Al-Kahafa project in Hail province. All four batteries will have a storage period of four hours.

Over a gigawatt of bids from battery storage project developers have been successful in the first-ever competitive auctions for low-carbon energy capacity held in Japan. A total 1.67GW of projects won contracts, including 32 battery energy storage system (BESS) totalling 1.1GW and three pumped hydro energy storage (PHES) projects totalling 577MW.

On 25 July 2024, the Bulgarian Ministry of Energy closed the open discussion on the terms and conditions for the upcoming battery energy storage system (BESS) tender, deciding that more than 3000 MWh will be funded by grants from the EU's Recovery Resilience Facility.¹

The ministry released a statement a day prior to the application window's opening. Energy minister Vladimir Malinov said the investments, worth up to BGN1,153,939,700 (US\$657.4 million) "will guarantee the security and stability of the Bulgarian electricity system."
