

Foreign Trade Zone Overview. The U.S. Foreign Trade Zone Program is an approved site that is outside of U.S. Customs territory and considered to be in international commerce. Companies using a Foreign Trade Zone are able to delay, reduce or eliminate duties on foreign goods admitted in the FTZ, and enjoy streamlined Customs processing.
