Pumped storage power plants and battery storage (large batteries and decentralised home storage), which only temporarily store energy and then feed it back into the grid, still dominate here.

They still make up the largest share of the electricity storage capacity in Germany; about 30 projects commissioned between 1926 and 2004 provide a total capacity of about 7 GW. The majority are operated by

utilities and they principally provide time-shifted electricity supply and balancing energy.
