Fotowatio Renewable Ventures took over a portfolio of 600 MW of battery energy storage systems under development in Greece. Greek company Wootis said it sold 51% of its subsidiary that owns eight licensed battery electricity storage system (BESS) projects to Fotowatio Renewable Ventures or FRV.

The island of Tilos in Greece's Aegean Sea is going to host the country's first renewable energy plus battery storage system. The microgrid will be able to support the island's population, replacing diesel generators.

Greece has emerged as one of the countries with the largest pipeline of battery storage projects, but as yet there has been little activity on the ground. This is changing as the long-awaited storage subsidy auctions have started, with the first projects being awarded support for both investment and operating costs.

The Regulatory Authority for Energy (RAE) of Greece revealed the shortlist of successful bidders in the second round of its auction for energy storage, totalling 1.5GW/3.1GWh of projects, last week (8 February). ... Capacity market (CM) auctions have concluded in Italy and Belgium and battery energy storage system (BESS) projects won the lion ...

Greece"s first energy storage tender took place last year. It awarded 12 energy storage projects, or 411,79 MW of capacity, with an average price of EUR49,748/MW per year. To conclude its energy storage auction program, Greece needs to run a third storage tender to account for the remainder of the program"s 1 GW of capacity.

The Greek authorities have awarded 300 MW of new battery storage capacity in its second energy storage tender. The 11 winning projects range in size from 8.875 MW/17.75 MWh to 49.9 MW/100 MWh. ... The auction will offer investment and operational support for four-hour independent energy storage units, with the tendered capacity total set at 300 MW. Energy-storage projects intended for installation at the country's former lignite regions of western Macedonia and Megalopolis - eastern Macedonia will also be added - will be eligible.

Greece plans to provide EUR 1 billion in state subsidies to support two solar power projects, with a total capacity of over 800 MW and with integrated energy storage units. The European Commission has given the green light for the subsidies, which will take the form of a two-way contract for difference over a period of twenty years.
