So, reducing energy consumption can inevitably help to reduce emissions. However, some energy consumption is essential to human wellbeing and rising living standards. Energy intensity can therefore be a useful metric to monitor. Energy intensity measures the amount of energy consumed per unit of gross domestic product.
