#### Haiti new market energy storage tender

The US Trade and Development Agency (USTDA) is promoting a Request for Proposals (RfP) to US companies to design, build and install hybrid solar PV and energy storage microgrid generation systems in Haiti. The RfP is being run by EarthSpark International - a small-scale clean energy product distributor that focuses in Haiti.

There is also a recognised need to stimulate demand for energy storage to get this growth started, something that was referred to by Power and New Renewable Energy minister RK Singh at a recent event where he said the government of India will also tender for 4,000MWh of storage. New opportunities emerge to offer stable revenues as the need for storage in Europe is rampant. energy storage and flywheel are a few effective technologies that make business sense. Furthermore, among these aforementioned technologies, BESS is expected to be the main driver for ESS growth globally in the coming years.

Wins for solar-plus-storage in tender "prove energy storage is integral to greener Germany" ... a 49% market share for systems between 30kWh to 1MWh in the country -- and a 20% share across Europe -- the national energy storage market in its home country "continues to play an important role for Tesvolt," the company representative said.

The Bulgarian Ministry of Energy has invited public comment on a new initiative to offer tenders for 3GWh of energy storage capacity to help integrate renewable energy. In its current form, the tender consists of BGN1.2 billion (US\$660 million) in grant funding.

"We have had this energy crisis for a long time, more than 20 years," says Evenson Calixte, managing director of Haiti"s Autorité Nationale de Ré gulation du Secteur de l"Energie (ANARSE), the nation"s energy regulatory authority. "And we believe that one element that can help reform this sector is private investment."

Haiti"s first tender for renewable energy mini-grids resulted in two private consortiums being selected to develop seven sites, with concessions likely signed in the near ...

Comparing tenders activity in energy storage segment in different regions of the globe, North America held the top position with ten tenders and a share of 45.5% during June 2021, followed by Asia-Pacific with six tenders and a 27.3% share and Middle East and Africa with four tenders and an 18.2% share.

The reverse auction was launched with a Notice Inviting Tender (NIT) issued by SECI on 15 March for the Request for Selection (RFS). Buying entities for the solar-generated power will set 2-hour periods each day during which energy will be drawn from the energy storage system (ESS), determined on a day-ahead basis.

For Haiti's Moïse, who has made the provision of energy nationwide the cornerstone of his presidency, the promise has taken on added urgency as the nation approaches general elections slated for 2021.

With the Exepedited LT1 and LT1 tenders added to the state-supported 250MW/1,000MWh Oneida energy storage project, the province has now secured 2,915MW of storage resources. Toronto-based developer Potentia Renewables got the biggest contract in the round at 390MW, for its 412.72MW nameplate capacity Skyview 2 BESS project in the ...
