

# Honiara energy storage subsidy policy update

The need to reduce greenhouse gas emissions has catalysed the rapid growth of renewable energy worldwide. However, the intermittent nature of renewable energy requires the support of energy storage systems (ESS) to provide ancillary services and save excess energy for use at a later time.

The Ministry of Energy ("MoE") is the ministry of the Bulgarian Government which executes the Governmental policy in the energy field. energy storage deployment have already seen positive results with the deployment of stationary energy storage growing from about 3 GW in 2016 to 10 GW in 2021. Subsidy policies for energy storage technologies are adjusted according to changes in market competition, technological progress, and other factors; thus, energy storage subsidy policies are uncertain. Sweden has announced a government subsidy that will cover 60% of the cost for installing a residential energy storage system, up to a maximum of 50,000 kroner (US\$5,400). Battery, wiring, management systems and installation will all be eligible for payment under the subsidy.

The need for storage capacity in Belgium is expected to increase from 7 GW to 12 GW in 2020. The main energy storage project in Belgium is the construction and operation of an offshore "energy atoll" (essentially a manmade offshore pumped-storage facility), for which the Electricity Act has been modified in 2014 (see below), in order to support offshore wind-generated ...
