Smart energy management strategies will thus be required for reliable and energy-efficient operation of the railway system. Many European energy-storage markets are growing strongly, with 2.8 GW (3.3 GWh) of utility-scale energy storage newly deployed in 2022, giving an estimated total of more than 9 GWh. Looking forward, the International Energy Agency (IEA) expects global installed storage capacity to expand by 56% in the next 5 years to reach over 270 GW by 2026.

The EERA Joint programme for Energy Storage is the first pan-European programme to bring together all major fields of energy storage research. JP ES therefore represents a unique opportunity to align research and development activities in the field.
