

## Hungary s household energy storage policy

Attila Steiner, Hungary's State Secretary for Energy and Climate Policy, said: "Hungary has a strong commitment to renewables. As the next step, the government's priority is to upgrade the national grid to be capable of integrating the rapidly growing electric capacity generated by weather-dependent energy sources.

Hungary has fulfilled its obligation as a storage facility and has continuously examined the security of supply situation. Consumption decreased by 20 % between August 2022 and March 2023, with wholesale gas prices on European markets returning to the range of EUR 25/MWh by May 2023.

The energy crisis hitting Europe from early 2022 and European Union expectations have prompted lawmakers to diversify Hungary's energy mix and consider reopening to wind energy. At the end of 2022, the energy minister had repeatedly indicated in several energy industry events that wind energy policy was due for a review.

The global energy markets of the last decade have been characterized by an ever-increasing share of electric power, more than half of which is projected to come from renewable energy sources by ...

Mass application of energy storage facilities will be needed to adapt the system to the spread of household green energy production, and the use of electric engines will be further boosted, it said. ... Hungary's gas storage facilities are at 90 percent. For Hungary, the EU set a ratio of 86 percent by Sept 1 which the country met already in ...

The new storage battery is set to be operational by 2025, making it easier and more cost-effective to store renewable energy. This development is expected to enable the green energy sector to make a greater contribution to Hungary's energy mix. The largest energy storage facility in Hungary currently has a capacity of only 7.68 MW.

The Government of Hungary has recently passed legislation regarding Hungary's approach to renewable storage, introducing significant changes aimed at creating a more favorable environment for energy storage providers.

The need for storage capacity in Belgium is expected to increase from 7 GW to 12 GW in 2020. The main energy storage project in Belgium is the construction and operation of an offshore "energy atoll" (essentially a manmade offshore pumped-storage facility), for which the Electricity Act has been modified in 2014 (see below), in order to support offshore wind-generated ...

The assistance program will be accessible to companies operating in Hungary's energy sector, excluding financial institutions.
