However, as EIA implemented the changes, the data quality deteriorated. The reality is that the oil market today is balanced, so sentiment can be easily swayed by market positioning. We see the oil market in the midst of a healing process, so it will take time.

Phase 2 was concluded today with EIA implementing "transfers to crude oil supply" in its weekly oil storage report. Phase 3 will include condensate and scrubber oil production in the monthly report.
