1 · SSE Renewables, a developer specializing in renewable energy projects, announced that it has acquired the project development rights for a 120 MW/240 MWh grid-scale battery ...

The launch of this first tender aimed to co-locate energy storage with other renewable sources, mainly solar PV, and aimed to fund at least 600MW of projects with a fund of EUR150 million (US\$162 million) in capital expenditure for the projects.. With a strong pipeline of further energy storage projects, Ireland's electricity system is becoming more flexible and agile facilitating the greater integration of cheaper renewable wind and solar power necessary to decarbonise the electricity system and meet Ireland's climate targets.

Updated 10 January 2021: Dr Marek Kubik, market director at Fluence told Energy-Storage.news and Solar Power Portal that the projects the company is working on with ESB represent a new phase in market development for Ireland's energy storage industry: "The majority of energy storage projects in the Irish Single Electricity Market have so far been 20-30min duration ...

Tata Power Solar's parent company Tata Power told Energy-Storage.news in December last year that there is "promising potential" for the energy storage industry in India, given the country's strong ambitions for deploying renewable energy. The project was awarded under the round of Germany's Innovation Tender programme for co-located renewable and storage projects which was concluded in 2021. The Innovation Tender is running annually until 2028 and a total of 5,450MW of capacity is expected to be procured in that time, consultancy Clean Horizon recently told Energy-Storage.news.

The project commissioning comes after German energy company RWE powered up a 60MW BESS last month in Ireland's County Monaghan. Mitsubishi Power revealed plans last week to enter the European energy storage market with four BESS projects totalling 371MWh for ION Renewables in Ireland. This story

Ireland has been one of the early movers in the European energy storage market along with the UK, with grid frequency response markets providing secure revenue services for projects. According to consultancy Delta-EE, it will have 1,400MW of BESS installed by the end of 2022 with 600MW coming online over the course of the year.

“No electricity system can operate without a backup. In Ireland this has traditionally been provided by fossil fuel generation. “However, into the future, we can store increasing amounts of wind and solar power in energy storage projects and use it to support the system instead of relying on dirty and expensive coal or gas,” he added.
