ROME : Italian energy storage company NHOA is under government scrutiny after its leading shareholder Taiwan Cement Corp (TCC) announced a buyout offer to take the Paris-listed company private ...

But what's happening now is that U.S. storage capacity is getting dangerously close to full. With this week's increase, the total is now at 444.37 million barrels of our roughly 600-million-barrel capacity.
