Japan's energy policy is guided by the principles of energy security, economic efficiency, environmental sustainability and safety (the "three E plus S"). The 5 th Strategic Energy Plan, adopted in 2018, aims to achieve a more diversified energy mix by 2030, with larger shares for renewable energy and restart of nuclear power.

Japan's government called the package of energy policies and their targets "ambitious." Energy security considerations may affect the progress and pace of decarbonization in the electric power sector.

The targeted increase in Japan's wind capacity focuses on increasing offshore capacity from 0.14 GW in 2022 to 10 GW by 2030. In March 2024, the Japanese government approved a draft amendment to allow offshore wind turbines to be installed in Japan's exclusive economic zone.
