Moreover, a number of Japan's leading energy companies, automakers, heavy industry companies, and financial entities have joined forces to promote hydrogen business and debate and recommend policy and regulatory conditions to realize a hydrogen economy (e.g., Japan Hydrogen Association, Clean Fuel Ammonia Association, and Japan H₂ Mobility).

Besides, unlike developed countries such as the United States and Japan, China has not yet regarded energy storage as an independent industry, it lacks the top-down design of energy storage payment mechanism, and

Japan, which first published its Basic Hydrogen Strategy in 2017, on Tuesday announced a revised target to boost hydrogen supply to 12 million tonnes a year by 2040. The initial plan called for hydrogen supply in Japan to reach 3 million tonnes annually by 2030 from 2 million tonnes now.
