The NYCIDA approved four battery ...

Developers and power plant owners plan to add 62.8 gigawatts (GW) of new utility-scale electric-generating capacity in 2024, according to our latest Preliminary Monthly Electric Generator Inventory. This addition would be 55% more added capacity than the 40.4 GW added in 2023 (the most since 2003) and points to a continued rise in industry activity.

On July 19, 2023, the Jiangsu Provincial Development and Reform Commission issued the Implementation Plan for the Development of New Energy Storage Projects in Coastal Areas (2023-2027). The plan proposes that by 2025, the cumulative operation scale of new energy storage projects in coastal areas will strive to reach about 2.5 million kilowatts.

The newly commissioned scale is 8.0GW/16.7GWh, higher than the new scale level last year (7.3GW/15.9GWh). The newly-added projects were mainly put into operation in June, and the capacity reached 3.95GW/8.31GWh, ...

1 &#0183; Keep Safe Distances: BESS projects must be placed at a safe distance from nearby property lines--either 50 feet or 20 feet, depending on the specifics of the project. Create a Fire Safety and Evacuation Plan: Every project must have a plan in place to ensure the safety of people in the event of a fire, including a clear evacuation plan.
