At present, many new PSH concepts and technologies are being proposed or actively researched. The report goes on to list some of the many challenges faced by pumped storage developers and include: Tax policy - Current federal tax policy means some energy storage technologies receive a 30% investment tax credit while pumped storage does not. This can make a substantial difference within a competitive utility procurement setting.

The goal is to develop at least 500MW of pumped storage hydropower by 2030, boosting Italy's energy autonomy and economic development. The partnership will focus on two pumped storage projects in Pescopagano, Basilicata, and Villarosa, Sicily.

The pumped storage project will have storage for 7.5 hours. Its capacity will be increased to 1.92GW with six hours of storage to provide a total storage of approximately 11GWh daily. According to the Indian company, the project will become the largest of its kind in the country. The hydropower facility will be an off stream open loop project.

Pumped storage might be superseded by flow batteries, which use liquid electrolytes in large tanks, or by novel battery chemistries such as iron-air, or by thermal storage in molten salt or hot rocks. Some of these schemes may turn out to be cheaper and more flexible. A few even rely, as pumped storage does, on gravity.

The current U.S. fleet of operating (single- speed) pumped storage plants does not provide regulation in the pump mode because the pumping power is "fixed" - a project must pump in "blocks" of power - though a single pumped storage facility may consist of multiple units and smaller blocks of power.
